

ASSESSMENT REQUIREMENTS

Training in Non-Invasive Interactive Neurostimulation (NIN) therapy using the InterX device is aimed at medical professionals and complementary therapists providing pain management and rehabilitation: Anaesthsists, Physiotherapists; pain nurses; occupational therapists, homeopaths, osteopaths, chiropractors, acupuncturists, sport massage therapists, etc.

- Initial training is provided by trained sales representative in the field.
- Further training is one-day training, module 1 (6 hours) attendance group training with the certified NRG CPD presenter. This Certification is of the attendance only.
- Advance Training
 - In order to achieve advance certification, a therapist is required:
 - to attend the advanced one-day training courses, module 2 (6 hours) with the certified NRG CPD presenter;
 - to produce 6 case-studies that demonstrates sufficient practical ability of the use of the InterX device;
 - to be able to produce a valid certification in Anatomy & Physiology;
 - to pass written and oral assessment at the end of the training course.

Optional attendance of the practical workshops one-day (6 hours) is aimed at enhancing practical skills in use of the InterX device organised by certified NRG CPD presenter.

Issued Certificates certify that the therapist is familiar with the safety of the use of the InterX device and achieved a proficiency in using it for a treatment of pain within the approved (MDD CE) claims. Certificates are issued and signed by certified NRG CPD presenter.

We recommend you to attend next step in training within one or two months after completing introductory "FOUNDATION", module 1 training course. Please try to use the device practically as much as possible and record at least six cases for study. Please see enclosed forms:

- intake forms, initial and follow up;
- case study assessment form.

When you attend the Advanced course with the "ASSESSMENT" and "COMPLEX NEUROPATHIC PAIN", there will be a brief assessment at the end of the training to evaluate your knowledge. In order to prepare yourself, please do re-vision on the following:

General:

- How the InterX works (general mechanisms as you would explain them to your patient)
- what are the treatment goals;
- indication / contra-indications for InterX therapy;
- what are the Active Sites;
- what are the three step treatment process;
- how to manage acute versus chronic pain;
- treatment planning;
- combination with other therapies

Case studies

You will be expected to present six case studies in order to show your ability to:

conduct a consultation;

- plan an appropriate course of treatment;
- utilise three-step treatment process;
- based on the patients complaints to determine where to treat, how often, when to do the break from the treatments
- monitor the patient's condition throughout the course of treatment

When writing up a case study include the following details: patient's details, initial symptoms, treatment, your notes for monitoring the progress throughout the course of treatment and outcome comparative criterion on pain score, function and pain medication intake. You may also be asked for some clarification on any particularly interesting aspect of the case. Try to choose different types of conditions to demonstrate your breadth of experience.

Lastly, do not write a lot, but give us essential information about the patient and your ability to give him/her an appropriate treatment. Only after accepted case studies, successful written and verbal assessment you will be granted a certificate of "fully accredited InterX Practitioner".
